DRUG FACILITATED SEXUAL ASSAULT TOXICOLOGY KITS

The use of "Date-Rape Drugs" such as Rohypnol™ ("Ruffies") and Gamma-Hydroxybutyrate ("GHB") is being reported more frequently in sexual assault cases throughout the country. Because of the amnesia effect of these drugs, the victim may not be able to remember all the details of the assault or may have difficulty identifying the assailant(s).

Our Drug Facilitated Sexual Assault Specimen Collection Kits (DFRE) are designed to be used in conjunction with your existing sexual assault evidence collection kits when victimizing drugs are suspected. The kit instruction sheets are written for medical personnel and assure proper collection and chain of custody. After the examination the kit is handed over to the investigating officer, along with the sexual assault evidence collection kit, for submission and analysis by the crime laboratory.

Child Physical Abuse Information and Specimen Collection Kit





Suspect DNA Buccal Swab Collection Kit



Our Buccal Swab Collection Kit is the least intrusive of our series of Suspect DNA Specimen Collection Kits and is designed for use by nonmedical personnel. The cotton-tipped swabs are placed in the subject's mouth and the inside of the cheek is vigorously swabbed, resulting in the transfer of buccal cells onto the cotton bulb of the swab. The kit is either mailed or hand delivered to the crime laboratory for "known" DNA analysis and comparison with "unknown" DNA from a crime scene.

Suspect DNA Finger Stick Blood Collection Kit



In most states our Finger Stick Blood Collection Kit can be used by nonmedical personnel. Using the sterile lancet provided, simply stick the subject's left or right ring finger, then squeeze the finger allowing the blood to fill the inner circles on the blood collection card. The kit is then sealed and forwarded to the crime laboratory for analysis.

Victim DNA Buccal Swab Collection Kit





Our Victim DNA Buccal Swab Collection Kit is designed for use by nonmedical personnel for the collection of "known" DNA from victims (both adult and minors). Simply swab the inside of the victim's cheek and gum line which will result in the transfer of buccal cells onto the cotton bulbs of the swabs.

After collection the kit is either mailed or hand delivered to the crime laboratory for comparison with "unknown" DNA found at the crime scene to corroborate the victim's testimony.

Criminal Paternity DNA Specimen Collection Kit



For the past several years, there has been a growing concern with young adults and pedophiles engaging in consensual sexual activities with minors. These relations often lead to the impregnation of the victim. These crimes of statutory rape or incest are often committed by persons in a position of authority or trust. The assailants use their position of power to cover up their crimes by coercing, intimidating, or manipulating their underage victims into undergoing a legal abortion, therefore eliminating any evidence that, through DNA typing, would link them to the minor.

Our Criminal Paternity DNA Specimen Collection Kit has been specifically developed for the collection of "known" DNA from the underage mother through buccal swabs and the surgically aborted embryonic or fetal tissue. This kit allows law enforcement officials to identify the biological father through DNA.

When the box is used in conjunction with refrigerant gel packs or dry ice, specimens will remain refrigerated or frozen for several days.

The Specimen Shipping Box is provided with two refrigerant gel pack labels affixed to the outside of the box and two "cover-up" dry ice labels which are affixed over the gel pack labels when dry ice is used to keep the specimen frozen while in transit to the laboratory.

Swab Box Envelopes to prevent cross-contamination

With our kit the investigating officer collects reference DNA samples from the missing person's biological parent(s), sibling, or children, and then submits the kit to the crime laboratory. The lab then enters the results in the family member database in the Missing Person's Index of the National DNA Database (CODIS). Having the biological family member(s) tested in advance expedites the identification of recovered remains.


CHILD IDENTIFICATION KIT

Child safety is a concern of parents, communities, and police throughout the country. When a child is reported missing, law enforcement agencies require accurate and current information about the child as quickly as possible in order to begin a search. In most cases, however, parents are so distraught they have difficulty answering even simple questions concerning their child.

Our Child Identification Kit is designed to eliminate these problems by providing police with photographs, thumbprints, and other pertinent information to assist in a rapid recovery of a missing or abducted child. Our kit also collects DNA saliva specimens which, in a worst-case scenario, would be used to make a positive identification of the child's remains.
